Essential to the function are excellent analytical skills, ability to communicate in a clear and structured manner, to identify potential issues and to propose solutions, excellent written and oral communication skills and a high sense of responsibility.</p> <p>The successful candidate should have proven experience in data, information and knowledge management, project management and extensive experience in writing analytical notes, briefings and project plans.
