This Unit carries out research in support of EU policies on migration and is responsible for the Knowledge Centre on Migration and Demography.</p> <p>The European Commission Knowledge Centre on Migration and Demography (KCMD) is a Commission's independent body – steered by all the relevant services – tasked to provide solid scientific evidence for the development, implementation and evaluation of migration and demographic policies, not only in the framework of the migration and refugee crisis, but also in managing migration and addressing the demographic decline in the medium to longer term.</p> <p>The KCMD is there to support and help to anticipate trends, and it serves the objectives of the European Agenda on Migration. The three pillars of the KCMD are:</p> <ol style="list-style-type: none">1) Building the evidence base, conducting analysis and foresight;2) Exploiting the knowledge base and facilitating uptake by stakeholders;3) Partnerships and networking to extend the knowledge base. The JRC is responsible for its daily activities. <p>The successful candidate will be expected to implement the activities of the Knowledge Centre on Migration and Demography (KCMD) aiming at collecting, classifying and putting into context existing knowledge on the EU external dimension of migration, i.e. geopolitics, development economics, migration and development.</p> <p>The job holder will be asked to contribute to one or more of the above topics taking care of the following tasks:</p> <ol style="list-style-type: none">(i) to update available knowledge on migration and demography topics;(ii) to classify available information, including contributions from KCMD actors and partners;(iii) to analyse, review and synthesize relevant researches;(iv) to make relevant knowledge easily available and usable for policy makers. <p>The work will require research, critical analysis and in particular editing and synthesis skills for the production of science for policy papers, technical reports and contribute to “flagship” reports. Additional tasks will include support to the activities of expert working groups and the organisation of seminars and thematic workshops.</p>
