In particular the work takes stock of the European Commission Communication (COM/2018/283 final) and tries address the problem using a holistic perspective by combining social sciences, economics and engineering.</p> <p>A multidisciplinary team is being established to analyse the job impact and employment intensity of all segments of the transport sector with a bottom-up data driven assessment approach.</p> <p>The present Contract Agent position will be part of this team. The successful candidate will work on the development of scenarios for the future evolution of road transport sector, support the development of the manufacturing and engineering related part of an employment model and perform employment scenario calculations.</p> <p>The work will be carried out in close collaboration with colleagues within the Directorate and other Directorates of the JRC. The preparation of reports and scientific publications are an integral part of the required tasks. It also involves contacts within and outside the Commission.</p> <p>Qualifications:</p> <p>The ideal candidate should have a university degree in transport related Economics, Engineering or Science or relevant research experience after the first degree giving access to doctoral studies</p> <p>We look for a person with strong interest on transport issues, who will have a good aptitude of taking initiative, developing new concepts and be a strong team player. This position offers a number of varied and interesting tasks in a friendly and well integrated Unit to a motivated, flexible and reliable colleague.</p> <p>Good command of English (B2) is required.
