The directorate provides independent scientific evidence for the development, implementation and evaluation of EU policies, mainly in the areas of standardisation, public health, food and feed safety and authenticity, cosmetics and other consumer products, medical devices, nanomaterials, taxation with a focus on frauds and a well-functioning internal market.</p> <p>The operational scientific research will take place in the unit Consumer Products Safety.</p> <p>Short description of activity:</p> <p>The aim of the ER Project CONFINE is to carry out the detailed physico-chemical characterization of novel, nanostructured ceria-based high capacity absorbent materials synthesised in particulate and nanofibre form. Additional activities will concentrate on the use of the sorbent for the recovery of rare or high value (non-nuclear) elements extracted from e.g. waste electronic components.</p> <p>Qualifications:</p> <ul style="list-style-type: none">• Completed university studies of at least three years attested by a diploma and at least five years of professional experience, alternatively a doctoral diploma in Chemistry, Materials Science or related field;• Practical experience of nanomaterials synthesis and characterisation methods including structural/morphological characterization methods such as electron-microscopy, specific surface area measurements (BET) and particle sizing by e.g. sedimentation and/or optical based methods (DLS, MALS) is essential;• Knowledge in surface chemistry (XPS) analysis and inorganic analytical chemistry methods such as ICP-MS, TXRF is an advantage;
