The selected candidate will be assigned to the ordinary/extraordinary/corrective maintenance of specific assets of the JRC Ispra Site (that can include buildings, roads, roofs, and other similar works etc.). He/she will act as project coordinator in the area of civil engineering works and will coordinate the operations of external companies (including the works of the Safety Coordinator, the Works' Supervisor, etc.).</p> <p>S/he will contribute to the administrative and financial management of the executed works (including preparation of calls for tenders) following rigorously the financial and other regulations of the European Commission.</p> <p>Qualifications:</p> <p>Thorough knowledge of using Microsoft Office tools (word, excel, outlook, powerpoint etc.) is essential.</p> <p>Capacity to work in both Italian (minimum B2) and English (minimum B2) is required.</p> <p>Experience in yard supervision, procurement, use of specific technical/architectural software, safety at work good practices will also be important assets.</p> <p>The ideal candidate is a strong team player, a colleague able to work simultaneously in different projects/dossiers and a person with an "eye" for maintenance.
