Experimental campaigns in real world conditions and in laboratory are also foreseen. Planning, processing, analysis and reporting activities are also specific tasks for this position.</p> <p>Qualifications:</p> <p>The ideal candidate should have completed university studies in mechanical engineering or in a similar field. A Ph.D. or at least 5 years of research experience after the first degree giving access to doctoral studies is an advantage. Experience in the execution of vehicle safety tests is an asset. Experience in handling experimental data and statistical analysis is an advantage. Specific knowledge about automotive and vehicle safety technology is an asset. Experience in publishing scientific results in peer-reviewed journals is an advantage.</p> <p>We look for a person with strong interest on transport issues, who will have a good aptitude of taking initiative, developing new concepts and be a strong team player.
