<p><b>Position for:</b> <b>FG IV –Evaluation Officer</b></p>	<p>As the science and knowledge service of the Commission, the mission of DG Joint Research Centre is to support EU policies with independent evidence throughout the whole policy cycle.</p> <p>The JRC is located in 5 Member States (Belgium, Germany, Italy, the Netherlands and Spain). Further information is available at: <a href="https://ec.europa.eu/jrc/">https://ec.europa.eu/jrc/</a></p> <p>The position is within the Strategy, Work Programme and Resources Directorate in the Quality Assurance and Evaluation Unit.</p> <p>The mission of the unit is to coordinate the JRC's planning and reporting under the Commission Strategic Planning and Programming (SPP), to coordinate evaluations, to monitor the implementation of risk management and internal control standards, and to steer the implementation of the integrated management system.</p> <p>The Quality Assurance and Evaluation Unit is looking for an evaluation officer who will provide methodological support to the further development of evaluation activities inside the JRC, and to assist with the implementation of the evaluation(s). The evaluation activities are concerned with gathering and assessing quantitative and qualitative evidence for the impact of JRC's research on science, policy-making and society at large. Designing appropriate performance (impact) indicators will be an important aspect of the job.</p> <p>The job holder will also be expected to support the scientific directorates in planning for high impact of their activities, and draft case studies. This involves close cooperation with JRC scientists, policy DGs and external experts.</p> <p>The job holder would also contribute to mapping/benchmarking the JRC's publication record, hence experience in bibliometrics would be an advantage. The evaluation activity is of particular importance since the JRC should develop a new framework for its internal evaluations in time for the next Framework Programme for Research (2021+).</p> <p>Qualifications:</p> <p>Candidates should have a degree in science, engineering, economics or political science (related to impact assessment or evaluation).</p> <p>A job related experience of at least two years would represent an advantage.</p> <p>A good knowledge of English (B2) is required.</p>
