<p><b>Position for:</b></p> <p><b>FGIII – Laboratory Technician</b></p>	<p>As the science and knowledge service of the Commission, the mission of DG Joint Research Centre is to support EU policies with independent evidence throughout the whole policy cycle.</p> <p>The JRC is located in 5 Member States (Belgium, Germany, Italy, the Netherlands and Spain). The selected candidate for this position will contribute to these tasks including the preparation/execution of experimental testing campaigns having the objective of monitoring the latest models of passenger cars to check their compliance with the current emission legislation. The results of these tests will be regularly published as information to the public as well as used to assess the robustness of the new Real Driving Emission tests procedure. Contributions to reports and scientific publications are an integral part of the required tasks.</p> <p>Qualifications:</p> <p>The ideal candidate should have completed post-secondary education studies attested by a diploma in engineering, physics or in a similar field, or secondary education studies attested by a diploma giving access to post-secondary education, and appropriate professional experience of three years.</p> <p>Experience in laboratory based activity is an advantage. Knowledge of vehicle emissions test procedure is an asset. Specific knowledge about vehicle technology and after-treatment devices is an advantage.</p> <p>Good knowledge of spoken and written English (B2) is required as well as good communication and interpersonal skills.</p>
