The successful candidate is expected to assist with the review of the SF BREF, to participate in large expert meetings and manage all related information flow.</p> <p><b>Qualifications:</b><br/>He/she will have the following duties:</p> <ul style="list-style-type: none"> <li>- steer the technical discussion/exchange of information with stakeholders on issues of interest to the review of the BREF;</li> <li>- research information relevant to the BREF and analyse and validate/peer reviewed information provided by stakeholders;</li> <li>- draft the BREF document based on the information.</li> </ul> <p>We are looking for an engineer, a chemist or a scientist with a good knowledge of industrial processes and related environmental issues in one or more of the areas covered by the IED (ex IPPC Directive). For this post it is essential to have a good understanding of process engineering, environmental issues and regulation of industry; an understanding of environmental policy in the EU; a thorough knowledge of the IED/IPPC Directives and the concepts within. It is important to have an open mind and positive attitude with the ability to assess submitted information; and to be able to participate in expert discussions and meetings. The successful candidate will be self-motivated, be able to meet project deadlines and be a strong team player.</p> <p>Candidates must have at the time of applying a PhD and 5 years professional experience or 10 years' research experience after university studies of at least 3 years attested by a diploma.</p> <p>A very good level of written and spoken English is essential and knowledge of at least another EU language is compulsory.</p> |
