<p>Position for:</p> <p>FGIV- Project Officer – Scientific Research</p>	<p>As the science and knowledge service of the Commission, the mission of DG Joint Research Centre is to support EU policies with independent evidence throughout the whole policy cycle.</p> <p>The JRC is located in 5 Member States (Belgium, Germany, Italy, the Netherlands and Spain). Further information is available at: https://ec.europa.eu/jrc/</p> <p>The JRC offers a post in the Water and Marine Resources Unit, which contributes with research and innovative solutions to sustainably manage water resources in the face of increasing trends of global population, urbanisation, pollution, over-exploitation, land use and climate change.</p> <p>The post is assigned to the JRC Fisheries and Aquaculture activities and particularly linked to the Common Fisheries Policy (CFP). The CFP, a major EU policy framework, aims to ensure that fishing and aquaculture are environmentally, economically and socially sustainable and that they provide a source of healthy food for EU citizens. The CFP is also exceptional in that the provision of scientific advice is required by legislation. CFP scientific advice is underpinned by the EU Data Collection Framework (DCF) that provides fisheries and aquaculture data to the scientific community. The JRC is strongly involved both in the DCF and the CFP scientific advice provision.</p> <p>We need an experienced scientist to join the JRC team supporting the EU DCF and the related scientific advice process. The new colleague will collaborate with the rest of the team and with European scientific experts. S/he will also work with European Commission Directorates-General based in Brussels as well as international organizations.</p> <p>Qualifications:</p> <p>The candidate must have a strong background in fisheries, marine or quantitative sciences and good interpersonal and communication skills.</p> <p>The candidate must have a PhD degree in any of these fields or, alternatively, at least 5 years of full time relevant research experience after the first University degree giving direct access to doctoral (PhD) studies.</p> <p>Essential requirement is expertise in the processing and analysis of fisheries data, and knowledge about CFP related legislation such as the DCF and the EU Landing Obligation.</p> <p>Preferential requirements are familiarity with scientific fora on scientific advice to fisheries management (e.g. STECF, ICES, GFCM). A record of scientific publishing and reports</p>
