In order to support the necessary logistical preparation for sampling, dispatching operations as well as for the handling and registration of incoming samples as well as the proper documentation and archiving of the generated measurement data, we are looking for skilled and open-minded clerical support with proven crafting skills in the operation and handling of water and water equipment such as pumps, conduits and equipment.</p> <p><b>Qualifications:</b></p> <p>The ideal candidate has a secondary formation with a proof-record of artisanal skills in hydraulics, plumbing, air-conditioning or similar.</p> <p>He should have a thorough knowledge in the operation and maintenance of pumps and conduits for water handling at different scales and a solid knowledge of office software (i.e. Excel, Word). Previous experience in the industrial, private sector is an asset.</p> <p>Knowledge of Italian language is necessary to interact with local enterprises involved in the dispatch operations.</p>
