**The current vacancy is in Directorate G, Nuclear Safety and Security, Unit: JRC Sites Radiation Protection and Security (JRC.G.1):** The unit G.1 is responsible for nuclear infrastructure and radiation protection on site. Within the unit, the sector Technical Infrastructure - to which the position is assigned – manages the safe operation of all mechanical and electrical installations as well as all building works at the nuclear site.

**WE PROPOSE:**

The jobholder will have to prepare and follow-up nuclear infrastructure projects according to safety and security standards. He/she will also plan maintenance works, acceptance tests on existing installations.

**WE LOOK FOR:**

The successful candidate shall have completed studies in engineering, preferably in supply engineering/energy efficiency or any other engineering field (mechanical, electrical, buildings, nuclear, chemical). A job-related experience of at least 1 year in program/project management is desirable. Experience in procurement/contract management is desirable. A job-specific training and an introduction to the Commission's IT tools will be provided. Language skills: good knowledge in German and/ or English is required; the other language would be an asset.

**INDICATIVE CONTRACT'S DURATION:**

36 months initial contract with possible renewals up to maximum 6 years.
