This Unit carries out research in support of EU policies in migration and related fields and is responsible for the day-to-day operation of the Knowledge Centre on Migration and Demography.</p> <p>The European Commission's Knowledge Centre on Migration and Demography (KCMD) established in June 2016 is steered by JRC, DG HOME, and seven other services. It is tasked with providing solid scientific evidence for EU policy makers in migration, supporting the European Agenda on Migration and focusing on migration and demography developments at global scale addressing both short and mid-to-longer term policy needs.</p> <p>The KCMD is there to map and structure existing knowledge on migration, address some of the key knowledge gaps through its own research, extend the knowledge through networking with external partners, and disseminate its findings and care for their uptake by EU policy makers. Its activity areas span from legal migration and integration, to the external dimension of migration, to underpinning work in innovative data sources and data analytics.</p> <p>We are looking for a Trainee to contribute to developing a research project on secondary movements of people seeking asylum in the European Union. Secondary movements occur when migrants, including people who have requested asylum, move out of the EU Member State in which they first arrived in order to seek protection or settlement elsewhere.</p> <p>In particular the individual, under supervision of the Traineeship adviser, will:</p> <ul style="list-style-type: none"><li>• collect, review and summarise the existing evidence of secondary movements in the research literature</li><li>• collate, manage and analyse quantitative data with information on forms of mobility of asylum seekers between Member States.
