<p><b>Position for:</b></p> <p>Trainee</p>	<p><b><u>Short description of activity:</u></b></p> <p>The internship focuses on the support to the investigation of the possibilities to establish better links and to identify synergies between existing Environmental schemes for organisations such as the Eco-Management and Audit Scheme (EMAS, REGULATION (EC) No 1221/2009) and the Organisation Environmental Footprint (OEF, Annex III to Recommendation 2013/179/EU).</p> <p>One of the objectives of the OEF and also of the AA 33406 with DG ENV on the OEF is to explore synergies with other existing tools on the level of organisations.</p> <p>Specific focus of the traineeship should lie on assisting to exploit the complementarity of tools like EMAS and the OEF especially for identifying relevant environmental indicators and in further specifying on how to deal with indirect impacts according to EMAS.</p> <p>Potential links with ongoing projects to learn about the exploitation of identified synergies in an applied context will be explored during the traineeship.</p> <p>The results should contribute to a better understanding of the possibilities and problems that come with the existence of similar but mainly complementary tools for managing environmental performance of organisations.</p> <p><b><u>Qualifications:</u></b></p> <p>The candidate shall have interest and knowledge in environmental management schemes on organisation and or site level (preferably at the level of bachelor or master degree) and have general knowledge of the Organisation Environmental Footprint.
