**Short description of activity:**

The Sustainable Transport Unit of JRC's Directorate for Energy, Transport, and Climate comprising more than 50 staff, provides scientific and technical support on clean and efficient fuels and vehicles for sustainable mobility. The Unit also supports policies on alternative fuels including electro-mobility.

Within the Unit, the project on "modelling for smart, clean, and efficient mobility", supports the implementation of the EU alternative fuels infrastructure directive (2014/94/EU). Infrastructure for fuels such as electricity, hydrogen, CNG, and LNG for various transport modes (road, air, water) are covered in this directive.

The directive requires that member states establish national policy frameworks for alternative fuels infrastructure and send them to the European Commission. The European Commission then evaluates these frameworks.

The trainee will support the assessment of the member states' national policy frameworks for alternative fuels infrastructure. She/he will work within a small research team and under the supervision of expert members of our Unit.

At the end of the traineeship, the trainee will have gained significant knowledge with hands-
